Housing Policy Update

To reduce the administrative burden placed on sponsors, AmeriCorps VISTA is removing the requirement that housing support must be paid directly to the landlord or leasing agent.

What has changed	What stays the same	
 Sponsors may now reimburse members directly for housing costs. 	 This is optional for sponsors. Benefit must be provided equally to all members serving at the site. 	 Support for housing can be provided in the form of: One-time security deposit Housing reimbursement support
	 Sponsors may not advance money directly to a member to supplement living expenses. 	 Sponsors may develop relationships with landlords or mortgage holders.
		 Support offered does not violate VISTA's legislation:
		Members must (to the maximum extent practicable) commit to live

among and at the economic level

of the people being served.

Housing Policy Update

- Announcement in <u>Monthly Sponsor Message</u>
 - Sent on Monday, Oct. 21
- Housing support may impact a member's reportable income.
 - For more information: Income Disregard letter (2023)
- Refer to the <u>Sponsor Handbook</u> for additional supplemental member benefits.
 - Please note this policy change will be reflected in the next iteration of member and sponsor handbooks.


