### **Funding Priorities:**

Consistent with the Serve America Act, AmeriCorps State and National will seek to fund programs in the following six focus areas that use an evidence-based approach to create community impact and solve community problems.

- Disaster Services
- Education
- Environmental Stewardship
- Healthy Futures
- Economic Opportunity
- Veterans and Military Families

CNCS is required to select at least two focus areas in making competitive AmeriCorps State and National Grants. For the 2018 AmeriCorps State and National competition, CNCS seeks to prioritize investment of national service resources in the following priority areas:

- Disaster Services improving community resiliency through disaster preparation, response, recovery, and mitigation
- Education improving student academic performance in Science, Technology, Engineering, and/or Mathematics (STEM)
- Economic Opportunity increasing economic opportunities for communities by engaging opportunity youth, either as the population served and/or as AmeriCorps members, to prepare them for the workforce
- Healthy Futures reducing and/or preventing prescription drug and opioid abuse.
- Veterans and Military Families positively impacting the quality of life of veterans and improving military family strength
- Governor and Mayor Initiatives
- Rural intermediaries that demonstrate measureable impact and primarily serve communities with limited resources and organizational infrastructure
- Safer communities
- Evidence-Based Intervention Planning Grants

• Encore Programs – programs that engage Americans age 55 and older

<u>Accountability</u>: AmeriCorps State and National will continue to place a high priority on accountability and will devote significant effort and resources to oversight and monitoring to maximize compliance with all applicable rules and regulations. Special efforts will be made to help partners and grantees implement performance measurement and comply with all administrative and financial reporting requirements.

<u>Performance Measure Adoption and Implementation:</u> For FY 2018, AmeriCorps State and National will continue to make available to its grantees all of the agency's 16 Priority Performance Measures and will continue to allow the use of Complementary Program Measures and applicant determined Performance Measures.

### **AmeriCorps VISTA FY 2018 Annual Plan**

FY Appropriation: \$92,364,000

Target Member Level: 7,500

### **Key Milestones**:

- October 2017: Issue Program Guidance (which articulates AmeriCorps VISTA programming priorities) to CNCS State Offices and Field
- October 2017 September 2018: Hold 35-40 Pre-Service Orientations and Supervisor Trainings (a combination of in-person and virtual events) to train new AmeriCorps VISTA members and supervisors
- November 2017: Host convening of VISTA sponsor organizations, in collaboration with Senior Corps, to facilitate long-term planning of disaster recovery efforts for those affected by recent Hurricanes

# **Programming Priorities:**

Founded in 1965, Volunteers in Service to America (VISTA) is a federal anti-poverty program designed to provide needed resources to nonprofit organizations and public agencies to increase their capacity to lift Americans out of poverty. AmeriCorps VISTA members build the organizational and financial capacity of local programs that help low-income Americans gain the skills and resources they need to break the poverty cycle.

This year, AmeriCorps VISTA will prioritize rural community development, Veterans, STEM, workforce development (e.g., apprenticeships), and projects that help prevent and treat opioid/drug abuse.

Ultimately, CNCS expects to invest no less than 80 percent of AmeriCorps VISTA resources toward building the capacity of programs and organizations in the following focus areas:

- Economic Opportunity (Workforce Development, Employment, Financial Literacy, Housing)
- Education (STEM, School Readiness, High School Graduation, and Post-Secondary Success)
- Healthy Futures (Opioid Recovery, Food Security)
- · Veterans and Military Families

AmeriCorps VISTA continues to build out its virtual training resources and is intensifying training and technical assistance for VISTA supervisors in FY18.

<u>Performance Measure Adoption and Implementation</u>: AmeriCorps VISTA will seek to support projects that demonstrate the effectiveness of their proposed intervention in addressing community needs. In addition to measuring project performance in

organizational and financial capacity building, AmeriCorps VISTA will measure the value members receive from their national service experience.

# AmeriCorps National Civilian Community Corps (NCCC) FY 2018 Annual Plan

### **Funding Priorities:**

The Serve America Act authorizes the AmeriCorps National Civilian Community Corps (NCCC) to operate a residential national service program that provides young people with leadership and team-building opportunities to meet national and community needs.

To evaluate the program's effectiveness and efficiency, AmeriCorps NCCC measures key objectives and targets, including the impact of member service and the opportunities and training provided to its members.

### <u>AmeriCorps NCCC Service Projects and Special Initiatives:</u>

In 2018, AmeriCorps NCCC project outreach and implementation will reflect a continued focus on the NCCC specific service areas as outlined in the Serve America Act: response to natural and other disasters, infrastructure improvement, environmental stewardship and conservation, energy conservation, and urban and rural development.

To further build upon programmatic strengths such as our residential design and intensive member training program, AmeriCorps NCCC will continue in its role as the agency's lead responders in times of disasters as well as disaster preparation, mitigation, and recovery.

AmeriCorps NCCC will continue its partnership with the Federal Emergency Management Agency (FEMA) to support the goal of an additional 1,000 AmeriCorps NCCC members, who will work solely on FEMA-sponsored projects during their term of service.

# **AmeriCorps NCCC Members:**

The Serve America Act mandates that AmeriCorps NCCC engage participants from economically, geographically, and ethnically diverse backgrounds. Additionally, AmeriCorps NCCC was directed to conduct outreach to increase participation of disadvantaged youth to a target enrollment of 50 percent by the year 2012. In 2018, we anticipate reaching more than 40 percent, accompanied by an aggressive strategy for keeping us moving toward the very ambitious goal. To meet this goal, AmeriCorps NCCC will continue to implement measures as outlined in AmeriCorps NCCC's Annual Recruitment plan, including:

- Leverage new contract recruiters to target all NCCC applicant requirements;
- Expand AmeriCorps NCCC recruitment efforts by conducting outreach to organizations and institutions that support youth from disadvantaged circumstances;
- Collaborate with state and local corps programs to promote second year of service opportunities with AmeriCorps NCCC among their membership;
- Promote AmeriCorps Week, Mayor's Day and all National Days of Service as opportunities to introduce school-aged children to service and volunteering;
- Increase use of all social media outlets to recruit new members; and
- Expand the strategic use of the approximately 20,000 AmeriCorps NCCC alumni in recruitment efforts to increase the applicant pool for Corps Members and Team Leaders and aggressively promote national service.

### Performance Measure Adoption and Implementation:

AmeriCorps NCCC will contribute to seven of the 16 agency-wide priority performance measures.

# Senior Corps: Retired Senior Volunteer Program (RSVP) FY 2018 Annual Plan

FY Appropriation: \$48,902,000 Target Volunteer Level: 200,810

### **Key Milestones**:

- Total estimated grant awards in FY 2018: 597
- Administrative renewal of grants competitively awarded in FY 2015 (as required by statute), to also including
  - Performance measures linking federal funding to outcomes
  - Increased funding for grantees proposing evidence-based programing
  - Increased funding to small grantees of up to \$40K
- Continuation of grants competitively awarded in FY 2014, 2016, and 2017
- Possible additional grant and/or non-grant activities, to be determined based on availability of FY 2018 funds, to include, among other things, augmentations for evidence-based programming and disaster services

### **Funding Priorities**:

- Competitive and continuation grants fulfilling program priorities
- Compete and award grant augmentation for evidence-based programing
- Technical assistance and training for grantees' compliance, financial management and tribal program implementation

### Performance Measure Adoption and Implementation:

All RSVP grants have been competed, and all successful applicants will have adopted the National Performance Measures. In FY 2018, all renewed grants will compete under a refinement of the previous performance measures. Previously, 10% of all volunteers need to be placed in outcome based performance measures. Beginning in 2016, in accordance with OMB's Uniform Guidance for grants, we began to link federal funding to outcomes. At the time of their administrative renewal, grantees are required to place one volunteer in a service activity that either leads to an outcome, or supports an evidence-based health promotion activity for every \$1,000 in annual federal funding. At the end of FY 2018, all grantees within the portfolio will have adopted the refined performance measure requirements.

# Senior Corps: Foster Grandparent Program (FGP) FY 2018 Annual Plan

FY Appropriation: \$107,702,000 Target Volunteer Level: 21,870

### **Key Milestones:**

- Total estimated grant awards in FY 2018: 328
- Competitive New Awards to Replace Relinquished in FY18: 10\*

Currently, all grants and Volunteer Service Years relinquished in any state are centralized to CNCS for budget contingencies. Priority uses for centralized funding will be a FGP competitive process to award a combination of augmentation of grants supporting evidence-based programs and replacement sponsor competitions.

\*The final number of replacement awards will be determined by the number of relinquishments received throughout the year. Replacement competitions will be posted for geographic services areas relinquished before June 30<sup>th</sup>.

In addition, all renewed grants will compete under a refinement of the previous performance measures. Previously, 75% of all FGP volunteers need to be placed in outcome based performance measures. Beginning in 2016, in accordance with OMB's Uniform Guidance for grants, we began to link federal funding to outcomes. At the time of their administrative renewal, grantees are required to place one Volunteer Service Year in a service activity that either leads to an outcome, or supports specific legacy programing associated with serving individuals with disabilities for every \$6,000 in annual federal funding. At the end of FY 2018, all grantees within the portfolio will have adopted the refined performance measure requirements.

### Senior Corps: Senior Companion Program (SCP) FY 2018 Annual Plan

In addition, all renewed grants will compete under a refinement of the previous performance measures. Previously, 90% of all volunteers need to be placed in outcome based performance measured. Beginning in 2016, in accordance with OMB's Uniform Guidance for grants, we began to link federal funding to outcomes. At the time of their administrative renewal, grantees are required to place one Volunteer Service Year in a service activity that either leads to an outcome, or supports specific legacy programing associated with serving individuals with disabilities for every \$6,000 in annual federal funding. At the end of FY 2018, all grantees within the portfolio will have adopted the refined performance measure requirements.

# Subtitle H FY 2018 Annual Plan (Volunteer Generation Fund, Call to Service – MLK and September 11th Days of Service)

FY Appropriation: \$4,800,000

### **Key Milestones**:

- September 11th Day of Service and Remembrance and MLK Day of Service
  - Continuation grants to be awarded noncompetitively for September 11<sup>th</sup> Day of Service: 4
  - Continuation grants to be awarded noncompetitively for MLK Day of Service: 4
- Volunteer Generation Fund
  - Continuation grants to be awarded noncompetitively: 15

### **Funding Priorities:**

- September 11th Day of Service and Remembrance: Grantees may competitively subgrant or work with partner agencies so that a portion of the federal funds are provided to eligible organizations to plan and carry out direct service activities. Grantees will plan and carry out direct service activities that honor those lost on September 11th, 2001 and those who rose in service as a result of that tragedy. Activities may include ongoing service learning, ongoing direct service, and planning leading up to the events, but the majority of activity takes place on or close to September 11th.
- MLK Day of Service: Grantees may competitively subgrant or work with partner agencies so that a portion of the federal funds are provided to eligible organizations to plan and carry out direct service activities. Activities may include ongoing service learning, ongoing direct service, and planning leading up to the events, but the majority of activity takes place on or close to the MLK holiday.
- Volunteer Generation Fund: Grantees must provide evidence that subgrantees have enhanced their capacity to fulfill the following requirements:
  - Engage local partner organizations that use volunteers in a collaborative process of planning and implementation for increasing the impact of volunteers in meeting critical needs
  - Provide relevant, competency-based volunteer roles and opportunities that attract and retain high caliber volunteers
  - Develop the internal operational and financial management systems that will provide organizational sustainability

# Performance Measure Adoption and Implementation:

Performance measures for Subtitle H funds must include reports on the number of community volunteers recruited and/or managed by CNCS supported organizations and national service participants.

9-11 Day of Service grantees were required to begin using National Performance Measures in FY 2015. Grantees use Performance Measures in the Focus Areas of Disaster Services and Veterans and Military Families as well as the key goal of Capacity Building. Grantees will continue to use Performance Measures in FY 2018.

MLK Day of Service grantees were required to begin using National Performance Measures in FY 2015. Grantees can use Performance Measures in all six CNCS Focus Areas as well as the key goal of Capacity Building. Grantees will continue to use Performance Measures in FY 2018.

## **AmeriCorps Affiliate FY 2018 Annual Plan**

FY Appropriation: \$7,100,000 in Education Awards

## **Key Milestones:**

- December 2017: FY 2018 Notice released; applications will be accepted and reviewed on a rolling basis two times during the year
- March and June: Applications due, results announced approximately 90 days after due date
- March 2018: Continuation Applications Due

### **Programming Priorities:**

Started in FY 2016, AmeriCorps Affiliate is a pilot initiative that created a stream of service – distinct from other AmeriCorps programs – relying on authorities in the Serve America Act that CNCS had not previously used. The new initiative created a 100 hour service term available only to AmeriCorps Affiliate and allows members as young as 14 to serve. The new service terms and youth component puts AmeriCorps Affiliate in the unique position to expand summer service opportunities.

<u>Performance Measure Adoption and Implementation:</u>

For FY 2018, CNCS will make available to its AmeriCorps Affiliate sponsors all of the agency's 16 Priority Performance Measures and will allow the use of Complementary Program Measures and applicant determined Performance Measures.

# State Commission Support Grants and Commission Investment Funds FY 2018 Annual Plan

FY Appropriation: \$23,839,250

Target Member/Volunteer Level: Not Applicable

# **Key Milestones**:

FY 2018 partial awards – December 2017

• FY 2018 balance of award– April/May 2018

### **Funding Priorities:**

As required by the National and Community Service Act, funding will be awarded on a formula basis to support State Service Commissions as they implement service as a strategy to address local problems, such as leading disaster response and readiness efforts, addressing high school dropout rates, increasing mentoring efforts, training and technical assistance, supporting persons with disabilities, and establishing volunteer centers, online matching platforms, and other systems to effectively engage citizens in service. Funds will also be used in their outreach to prospective AmeriCorps grantees, administration of grant competitions, oversight and monitoring of grants and programs.

In addition, Commission Administrative Grants and Commission Investment Funds will be used to cultivate high-performing organizations by strengthening their training and technical assistance, accountability, and grant oversight activities.

Each State Service Commission is required to report on a standard performance measure that is selected by CNCS as well select any additional performance measures it determines based on individual state service plan.
