# AmeriCorps State and National FY 2020 Annual Plan

**Purpose of Plan**: The Annual Plan authorizes each of the CNCS programs and authorized staff from other CNCS units to make grants and/or enroll (or authorize grantees to enroll) eligible individuals as AmeriCorps members. National Service Position authorizations in the plan are issued to each AmeriCorps program as Member Service Years (MSYs).

For the AmeriCorps VISTA and AmeriCorps NCCC programs, an MSY authorizes the program to enroll a single individual as an AmeriCorps member. An AmeriCorps VISTA MSY is equal to 12 months of full-time service (or approximately five Summer Associate terms). For AmeriCorps State and National, an MSY authorizes the enrollment of a single full-time member or a combination of part-time, reduced part-time, or minimum time members that will equal 1700 hours of service.

Funding Allocation: \$416,510,000 (after reservation of funds under sec. 501(a)(6) of the NCSA)<sup>1</sup>

Target MSY Level: 67,304

- FY 2020 Awards: May 1, 2020
- FY 2021 NOFO Release: Summer 2020
- Annual AmeriCorps State and National Symposium: August/September 2020

# **Funding Priorities**

Consistent with the Serve America Act, AmeriCorps State and National will seek to fund programs in the following six focus areas that use an evidence-based approach to create community impact and solve community problems:

- Disaster Services
- Education
- Environmental Stewardship
- Healthy Futures
- Economic Opportunity
- Veterans and Military Families.

Congress requires CNCS to select at least two focus areas per year for AmeriCorps State and National Grants. For the 2020 AmeriCorps State and National competition, CNCS seeks to prioritize investment of national service resources in the following six priority areas:

- Be assessed as having Moderate or Strong evidence by the reviewers or
- Increase economic opportunities for communities by preparing people for the workforce.
- Education. In order qualify for this priority, the applicant must be assessed as having Moderate or Strong evidence by the reviewers.
- Healthy Futures. In order to qualify for this priority, the applicant must either
  - Be assessed as having Moderate or Strong evidence by the reviewers, OR
  - Reduce and/or prevent prescription drug and opioid abuse.
- Veterans and Military Families In order to qualify for this priority, the applicant must be positively impacting the quality of life of veterans and improving military family strength.
- Rural Intermediaries In order to qualify for this priority, the applicant must be an organization that demonstrates measurable impact and primarily serves rural communities with limited resources and organizational infrastructure.
- Faith-Based Organizations.

Examples of prior CNCS funded programs which have shown evidence-based effectiveness in the areas of Economic Opportunity, Education and Healthy Futures are available on the CNCS Evidence Exchange.

# Performance Measures

AmeriCorps State and National continues to require competitive grantees to use the agency-wide performance measures or applicant-determined performance measures.

#### AmeriCorps VISTA FY 2020 Annual Plan

#### Funding Allocation: \$92,364,000<sup>2</sup>

#### Target Member Level: 8,000

#### Key Milestones

- October 2019: Issue Program Guidance (which articulates AmeriCorps VISTA programming priorities) to CNCS Regional/Field Offices
- October 2019 September 2020: Hold Virtual Member Orientations and Virtual Supervisor Orientations throughout the year, along with 12 in-person In-Service Trainings/Convenings for VISTA members and supervisors

#### **Funding Priorities**

This year, AmeriCorps VISTA will prioritize rural community development, veterans, STEM, workforce development (e.g., apprenticeships), projects that help prevent and treat opioid/drug abuse, and access to broadband and digital literacy.

Ultimately, CNCS expects to invest no less than 80 percent of AmeriCorps VISTA resources toward building the capacity of programs and organizations in the following focus areas:

- Economic Opportunity (Workforce Development, Employment, Career and Technical Education, Affordable Housing, Eviction Prevention, Bridging the Digital Divide)
- Education (STEM, School Readiness, High School Graduation, Post-Secondary Success)
- Healthy Futures (Opioid Prevention/Intervention/Recovery, Food Security, Mental Health Services)
- Veterans and Military Families

AmeriCorps VISTA continues to build out its virtual training resources and is intensifying training and technical assistance for VISTA supervisors in FY 2020.

#### **Performance Measures**

AmeriCorps VISTA will seek to support projects that increase organizational and financial capacity and demonstrate the effectiveness of their proposed intervention in addressing community needs. AmeriCorps VISTA will also measure member satisfaction.

# **Funding Priorities**

The Serve America Act authorizes the AmeriCorps National Civilian Community Corps (NCCC) to operate a residential national service program that provides young people with leadership and team-building opportunities to meet national and community needs.

To evaluate the program's effectiveness and efficiency, AmeriCorps NCCC measures key objectives and targets, including the impact of member service and the opportunities and training provided to its members.

AmeriCorps NCCC Service Projects and Special Initiatives

In 2020, AmeriCorps NCCC project outreach and implementation will reflect a continued focus on the NCCCspecific service areas as outlined in the Serve America Act: response to natural and other disasters, infrastructure improvement, environmental stewardship and conservation, energy conservation, and urban and rural development.

To further build upon programmatic strengths such as our residential design and intensive member training program, AmeriCorps NCCC will continue in its role as the agency's lead responders in times of disasters as well as disaster preparation, mitigation, and recovery.

AmeriCorps NCCC will continue its partnership with the Federal Emergency Management Agency (FEMA) to support the goal of an additional 1,000 AmeriCorps NCCC members, who will work solely on FEMA-sponsored projects during their term of service.

The Serve America Act mandates that AmeriCorps NCCC engage participants from economically, geographically, and ethnically diverse backgrounds. In addition, Congress directed AmeriCorps NCCC to conduct outreach to increase participation of disadvantaged youth to a target enrollment of 50 percent by the year 2012. In 2020, we anticipate reaching more than 40 percent, accompanied by an aggressive strategy for keeping us moving toward the very ambitious goal. To meet this goal, AmeriCorps NCCC will continue to implement measures as outlined in AmeriCorps NCCC's Annual Recruitment plan, including:

- Leverage new contract recruiters to target all NCCC applicant requirements
- Expand AmeriCorps NCCC recruitment efforts by conducting outreach to organizations and institutions that support youth from disadvantaged circumstances
- Collaborate with state and local corps programs to promote second year of service opportunities with AmeriCorps NCCC among their membership
- Promote AmeriCorps Week, National Service Recognition Day, and all National Days of Service as opportunities to introduce school-aged children to service and volunteering
- Increase use of social media outlets to recruit new members
- Expand the strategic use of the approximately 24,000 AmeriCorps NCCC alumni in recruitment efforts to increase the applicant pool for corps members and team leaders and aggressively promote national service

#### Performance Measures

AmeriCorps NCCC will contribute to the seven applicable measures of the agency-wide performance measures.

# Senior Corps: Retired Senior Volunteer Program (RSVP) FY 2020 Annual Plan

Funding Allocation: \$50,355,0004

Target Volunteer Level: 183,000

#### **Key Milestones**

- Total Estimated Grant Awards in FY 2020: 550
- 2020 RSVP National Competition for grants initially competitively awarded in FY 2014 and administratively renewed in FY 2017 (as required by statute).
- Continuation of grants competitively awarded in FY 2015, 2016, and administrative renewal of 2017 expansion grants (as required by statute).
- Possible additional grant and/or non-grant activities such as outreach, to be determined based on availability of FY 2020 funds, to include, among other things, augmentations for evidence-based programming, permanent augmentations for baseline funding for volunteer recruitment and disaster response.

# **Funding Priorities**

The 2020 RSVP Competition Notice prioritizes grantmaking in the six focus areas identified by the Serve America Act of 2009 and in alignment with the CNCS Strategic Plan: *Disaster Services; Economic Opportunity; Education; Environmental Stewardship; Healthy Futures; and Veterans and Military Families*. Within the six focus areas, Senior Corps funding priorities include:

- Evidence-Based Program Implementation
- Access to Care Opioid Abuse
- Aging in Place Elder Justice
- Aging in Place Independent Living
- Economic Opportunity Workforce Development
- Education Intergenerational Programming
- Disaster Services
- Veterans and Military Families

#### **Performance Measures**

RSVP projects must use standardized Performance Measures as part of a comprehensive performance measurement strategy that relies on both performance and evaluation data to learn from their work and make tactical and strategic adjustments to achieve their goals. All unduplicated RSVP volunteers must be integrated into the Performance Measure work plans included in the application. Work plans must meet the maximum

cost per unduplicated volunteer in outcome assignments. For every \$1,000 in annual base federal funding, at least one unduplicated RSVP volunteer must be placed in work plans that result in Performance Measure Outcomes.



# Senior Corps: Foster Grandparent Program (FGP) <sup>5</sup> FY 2020 Annual Plan

Funding Allocation: \$110,899,000

Target Volunteer Level: 22,000

#### **Key Milestones**

- Total Estimated Grant Awards in FY 2020: 290
- FY 2020 renewal and continuation grants will be awarded non-competitively (as required by statute)
- FY 2020 FGP Replacement Competition
- Possible additional grant and/or non-grant activities, to be determined based on availability of FY 2020 funds; if available appropriations, Senior Corps will raise the stipend from \$2.65 per hour to \$3.00 per hour

Currently, all grants and volunteer service years relinquished in any state are centralized to CNCS for budget contingencies. Priority uses for centralized funding will be an FGP competitive process to award a combination of augmentation of grants supporting evidence-based programs and replacement sponsor competitions.

- Possible additional grant and/or non-grant activities, to be determined based on availability of FY 2020 funds; if available appropriations, Senior Corps will raise the stipend from \$2.65 per hour to \$3.00 per hour

# Subtitle H FY 2020 Annual Plan (Volunteer Generation Fund, Call to Service – Martin Luther King Jr. and September 11th Days of Service)

Funding Allocation: \$7,600,0007

Target Member/Volunteer Level: Not Applicable

#### **Key Milestones**

- September 11<sup>th</sup> National Day of Service and Remembrance and MLK Day of Service
  - o June 2020 Competitive grants to be awarded for MLK Day of Service
  - o June 2020 Continuation grants to be awarded for both days of service
- Volunteer Generation Fund
  - New and recompete applications will be awarded competitively and continuation grants will be awarded noncompetitively

# **Funding Priorities**

- September 11<sup>th</sup> National Day of Service and Remembrance: Grantees may competitively subgrant or work with partner agencies so that a portion of the federal funds are provided to eligible organizations to plan and carry out direct service activities. Grantees will plan and carry out direct service activities that honor those lost on September 11<sup>th</sup>, 2001 and those who rose in service as a result of the tragedy. Activities may include ongoing service learning, ongoing direct service, and planning leading up to the events, but the majority of activity takes place on or close to September 11<sup>th</sup>.
- MLK Day of Service: Grantees may competitively subgrant or work with partner agencies so that a portion of the federal funds are provided to eligible organizations to plan and carry out direct service activities. Activities may include ongoing service learning, ongoing direct service, and planning leading up to the events, but the majority of activity takes place on or close to the MLK holiday.
- Volunteer Generation Fund: Grantees must provide evidence that subgrantees have enhanced their capacity to fulfill the following requirements:
  - Engage local partner organizations that use volunteers in a collaborative process of planning and implementation for increasing the impact of volunteers in meeting critical needs
  - Provide relevant, competency-based volunteer roles and opportunities that attract and retain high caliber volunteers
  - Develop the internal operational and financial management systems that will provide organizational sustainability.

# State Commission Support Grants & Commission Investment Funds FY 2020 Annual Plan

Funding Allocation: \$17,538,000 and \$8,500,000

Target Member/Volunteer Level: Not Applicable

#### **Key Milestones**

• FY 2020 awards: December 2020

#### **Funding Priorities**

As required by the National and Community Service Act, funding will be awarded on a formula basis to support State Service Commissions as they implement service as a strategy to address local problems, such as: leading disaster response and readiness efforts; addressing high school dropout rates; increasing mentoring efforts; providing training and technical assistance; supporting persons with disabilities; and establishing volunteer centers, online matching platforms, and other systems to effectively engage citizens in service. Funds will also be used in their outreach to prospective AmeriCorps grantees, administration of grant competitions, and oversight and monitoring of grants and programs.

In addition, Commission Administrative Grants and Commission Investment Funds will be used to cultivate high-performing organizations by strengthening their training and technical assistance, accountability, and grant oversight activities.

#### **Performance Measures**

Each State Service Commission is required to report on standard performance measures.
