Purpose of Plan: The Annual Plan authorizes AmeriCorps State and National, VISTA, and National Civilian Conservation Corps (NCCC) programs and authorized agency staff to make grants and/or enroll (or authorize grantees to enroll) eligible individuals as AmeriCorps members. It also authorizes AmeriCorps Seniors to award grants.

National Service Position authorizations in the plan are issued to AmeriCorps State and National, VISTA, and NCCC programs as Member Service Years (MSYs). For the AmeriCorps VISTA and AmeriCorps NCCC programs, an MSY authorizes the program to enroll a single individual as an AmeriCorps member. For AmeriCorps VISTA, an MSY is equal to 12 months of full-time service (or approximately five Summer Associate terms). For AmeriCorps State and National, an MSY authorizes the enrollment of a single full-time member or a combination of three-quarter time, part-time, reduced part-time, minimum time, or abbreviated time members that will equal 1700 hours of service.

Funding Priorities

Consistent with the Serve America Act of 2009, AmeriCorps State and National will seek to fund programs in the following six focus areas that use an evidence-based approach to create community impact and solve community problems:

- Disaster services
- Education
- Environmental stewardship
- Healthy futures
- Economic opportunity
- Veterans and military families.

Congress requires AmeriCorps to select a minimum of two focus areas per year for AmeriCorps State and National Grants. For the 2021 AmeriCorps State and National competition, AmeriCorps seeks to prioritize investment of national service resources in the following areas:

• Efforts to help local communities recover from the COVID-19 pandemic. Applicants may propose programming in any AmeriCorps focus area to aid communities as they recover from the COVID-19 pandemic.

- Programs that actively engage in removing structural racial inequities, advancing racial equality, and increasing opportunity in order to achieve sustainable change in communities.
- Economic opportunity a program model that increases economic opportunities for communities by preparing people for the workforce.
- Education see sixth bullet, evidence-based interventions.
- Healthy futures a program model that reduces and/or prevents prescription drug and opioid abuse.
- Evidence-based interventions on the AmeriCorps Evidence Exchange (https://www.nationalservice.gov/impact-our-nation/evidence-exchange) that are assessed as having Moderate or Strong evidence.
- Veterans and military families a program model that positively impacts the quality of life of veterans and improves military family strength.
- Rural intermediaries organizations that demonstrate measurable impact and primarily serve rural communities with limited resources and organizational infrastructure.
- Faith-based organizations.
- Programs that reduce child poverty.
- Environmental stewardship.
- Economic Mobility Corps a joint initiative with the Community Development Financial Institutions Fund to place national service members at Certified Community Development Financial Institutions to enhance their capacity to provide financial literacy, financial planning, budgeting, saving, and other financial counseling activities in distressed and underserved areas.

AmeriCorps State and National continues to require competitive grantees to use the agency-wide performance measures or applicant-determined performance measures.

Funding Priorities

This year, AmeriCorps VISTA will prioritize COVID-19 response, rural community development, veterans, STEM, workforce development (e.g., apprenticeships), projects that help prevent and treat opioid/drug abuse, and access to broadband and digital literacy.

Ultimately, AmeriCorps expects to invest resources in its VISTA program toward building the capacity of initiatives in the following focus areas:

- Economic opportunity (housing and eviction prevention, employment/workforce development, and bridging the digital divide)
- Education (school readiness, K-12 success, Career and Technical Education (CTE), post-secondary success, and STEM, including remote learning in all areas
- Healthy futures (access to health care particularly in response to the COVID-19 pandemic, food security, and opioid addiction prevention and recovery)
- Veterans and military families (economic opportunity, education, and healthy futures)
- Priority populations: rural communities, Indian country, and areas of concentrated poverty
- Additional priority consideration: projects that work in the above areas and populations that address issues of racial equity.

AmeriCorps VISTA continues to build out its virtual training resources and is intensifying training and technical assistance for AmeriCorps VISTA supervisors in FY 2021.

AmeriCorps VISTA projects continue to use the agency-wide performance measures to demonstrate the effectiveness of their proposed intervention in addressing community needs.

Funding Priorities

The Serve America Act of 2009 authorizes the AmeriCorps National Civilian Community Corps (NCCC) to operate a residential national service program that provides young people with leadership and team-building opportunities to meet national and community needs.

To evaluate the program's effectiveness and efficiency, AmeriCorps NCCC measures key objectives and targets, including the impact of member service and the opportunities and training provided to its members.

AmeriCorps NCCC Service Projects and Special Initiatives

In 2021, AmeriCorps NCCC project outreach and implementation will reflect a continued focus on the program's specific service areas as outlined in the Serve America Act of 2009: response to natural and other disasters, infrastructure improvement, environmental stewardship and conservation, energy conservation, and urban and rural development.

To further build upon programmatic strengths such as our residential design and intensive member training program, AmeriCorps NCCC will continue in its role as the agency's lead responders in times of disasters as well as disaster preparation, mitigation, and recovery.

AmeriCorps NCCC will continue its partnership with the Federal Emergency Management Agency (FEMA) to support the goal of up to an additional 1,000 AmeriCorps members in its NCCC program who will work solely on FEMA-sponsored projects during their term of service.

AmeriCorps Members in NCCC

The Serve America Act of 2009 mandates that AmeriCorps NCCC engage participants from economically, geographically, and ethnically diverse backgrounds. In addition, Congress directed AmeriCorps NCCC to conduct outreach to increase participation of disadvantaged youth to a target enrollment of 50 percent by the year 2012. In 2021, we anticipate reaching more than 40 percent, accompanied by an aggressive strategy for keeping us moving toward the very ambitious goal. To meet this goal, AmeriCorps NCCC will continue to implement measures as outlined in the program's Annual Recruitment plan, including:

- Leverage new contract recruiters to target all AmeriCorps NCCC applicant requirements
- Expand AmeriCorps NCCC recruitment efforts by conducting outreach to organizations and institutions that support youth from disadvantaged circumstances
- Collaborate with state and local corps programs to promote second year of service opportunities with AmeriCorps NCCC among their membership
- Promote AmeriCorps Week, National Service Recognition Day, and all National Days of Service as opportunities to introduce school-aged children to service and volunteering
- Increase use of social media outlets to recruit new members
- Expand the strategic use of the approximately 24,000 AmeriCorps alumni from the NCCC program in recruitment efforts to increase the applicant pool for corps members and team leaders and aggressively promote national service

AmeriCorps Seniors RSVP FY 2021 Annual Plan

Funding Allocation: \$49,220,829⁴

Target Volunteer Level: 183,000

Key Milestones

- Fall of FY 2021: Augmentations for all AmeriCorps Seniors programs in support COVID-19 pandemic response, technology and infrastructure to serve virtually during pandemic.
- Spring and Summer 2021: Award competitive grants initially awarded competitively in FY 2015 and administratively renewed in FY 2017 as required by statute
- Spring and Summer 2021: Award continuation grants competitively awarded in FY 2016, 2017, and 2018, and administrative renewal of expansion grants as required by statute

Funding Priorities

The agency plans to make a total of approximately 630 grants through RSVP this year. The FY 2021 AmeriCorps Seniors RSVP Competition Notice prioritizes grantmaking in the six focus areas identified by the Serve America Act of 2009 and in alignment with the AmeriCorps Strategic Plan: Disaster Services; Economic Opportunity; Education; Environmental Stewardship; Healthy Futures; and Veterans and Military Families. Within the six focus areas, funding priorities for the RSVP program include:

- Evidence-based program implementation
- Access to care opioid abuse
- Aging in place elder justice
- Aging in place independent living
- Economic opportunity workforce development
- Education intergenerational programming
- Disaster services

In addition to the six focus areas identified in the Service America Act of 2009, the agency is also prioritizing RSVP projects that actively engage in removing structural racial inequities, advancing racial equality, and increasing opportunity in order to achieve sustainable change in communities and/or help local communities recover from the COVID-19 pandemic. Applicants may propose programming in any focus area to aid communities as they recover from the COVID-19 pandemic.

Performance Measures

AmeriCorps Seniors RSVP projects must use standardized Performance Measures as part of a comprehensive performance measurement strategy that relies on both performance and evaluation data to learn from their work and make tactical and strategic adjustments to achieve their goals. All unduplicated AmeriCorps Seniors volunteers in the RSVP program must be integrated into the Performance Measure work plans included in the application. Work plans must meet the maximum cost per unduplicated volunteer in outcome assignments. For every \$1,000 in annual base federal funding, at least one unduplicated AmeriCorps Seniors volunteer in RSVP must be placed in work plans that result in Performance Measure Outcomes.



AmeriCorps Seniors Foster Grandparent Program FY 2021 Annual Plan

Funding Allocation: \$114,550,628⁵

Target Volunteer Level: 22,000

Key Milestones

- March and June 2021: award approximately 325 renewal and continuation grants non-competitively as required by statute

- Spring 2021: consider additional grant and/or non-grant activities to be determined based on availability of FY 2021 funds

Currently, all grants and volunteer service years relinquished in any state are centralized to AmeriCorps for budget contingencies. Centralized funding will be used for competitive augmentation awards that support evidence-based programs and expansion sponsor competitions.

Funding Priorities

As required by the National and Community Service Act, funding will be awarded on a formula basis to support State Service Commissions as they implement service as a strategy to address local problems, such as: leading disaster response and readiness efforts; addressing high school dropout rates; increasing mentoring efforts; providing training and technical assistance; supporting persons with disabilities; and establishing volunteer centers, online matching platforms, and other systems to effectively engage citizens in service. Funds will also be used in their outreach to prospective AmeriCorps grantees, administration of grant competitions, and oversight and monitoring of grants and programs.

In addition, Commission Administrative Grants and Commission Investment Funds will be used to cultivate high-performing organizations by strengthening their training and technical assistance, accountability, and grant oversight activities.

Performance Measures

Each State Service Commission is required to report on standard performance measures.
