AmeriCorps State and National (ASN)



- Awards grants to non-profits, local and state government, Indian tribes, and institutions of higher education
- Grant recipients provide opportunities for individuals – AmeriCorps members – to serve communities across the country
- Since 1994, more than **1 million** individuals have provided service as AmeriCorps members

Training citizens in disaster preparedness



Improving the housing situation for economically disadvantaged people



Improving the academic performance or academic engagement of K-12 students



Improving the environmental condition of distressed public lands and waterways



Responding to the COVID-19 crisis



Increasing access to food resources for economically disadvantaged individuals

ASN Grants



- Utilize AmeriCorps members to build capacity or deepen the impact of the service to individuals or communities
- Broaden the scope of the service activities to reach previously underserved communities

Public Health AmeriCorps Overview



- Partnership with Centers for Disease Control (CDC)
- \$400 million investment over 5 years
- ARP funds Partnership with Centers for Disease Control (CDC)
- \$400 million investment over 5 years
 - ARP funds
- Workforce funding that will enable the recruitment, training, and development of a new generation of public health leaders who are ready to respond to the public health needs of the nation by providing public health service in communities



Priorities



- Generate a new generation of public health leaders who are ready to respond to the public health needs of the nation by providing public health service in communities
- Efforts to help local communities respond to and recover from the COVID-19 pandemic
- Applicants may propose programming to aid communities in their efforts to recover from the COVID-19 pandemic



Public Health AmeriCorps (PHA): Goals



Goals:

- Help meet public health needs of local communities by providing needed capacity and support in state and local public health settings
- Provide pathways to good quality public health-related careers through onsite experience, training, and more, with a focus on recruiting AmeriCorps members who reflect the communities in which they will serve



Eligibility



- The following non-Federal entities (all of which are defined in [2 CFR 200.1](#)) are eligible to apply:
 - Indian Tribes
 - Institutions of higher education
 - Local governments
 - Nonprofit organizations
 - States and US Territories



Types of Applicants

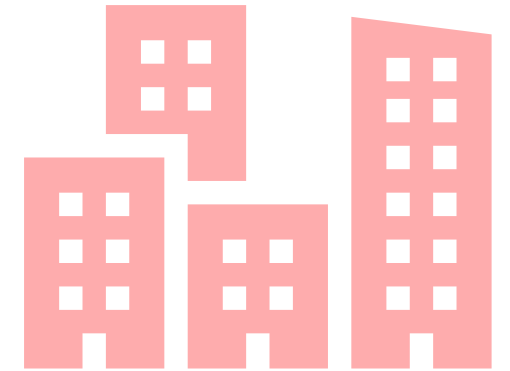


1. Single-State Applicants

- *Organizations that propose to operate in only one state will apply as National Directs and then if funded, be administered by the Governor-appointed State or Territory Service Commission*

2. National Direct Applicants

- *Multi-State*
- *States and Territories without Commissions*
- *Federally recognized Indian Tribes*



State Service Commissions



- Comprised of governor appointed boards who oversee the implementation of service and volunteer initiatives in their state
- Host portfolio of single state programs
- Employ staff that manage, monitor and evaluate the programs
- Provide feedback to AmeriCorps on the multi-state programs operating in their state



ASN Program Responsibilities



- Recruit, interview, and select members
- Provide regular training and supervision to members
- Track and report on performance measures
- Fiscal management and reporting



PHA Member Service



- AmeriCorps members will serve:
 - Primarily in state, local, tribal, and territorial public health departments OR
 - In service to public health departments
- Strongly recommended that AmeriCorps members serve in at least teams of two
- Examples of member service activities:
 - Community outreach
 - Health education
 - Mental health education and awareness, emotional regulation skill building
 - Health and social services navigation
 - Crisis response (e.g. COVID, Opioids, suicide, mental health)
 - Capacity building

- Three-year Grant
- Cost Reimbursement
- FT = Full time, TQT = Three Quarter Time, HT= Half Time, RHT = Reduced Half Time

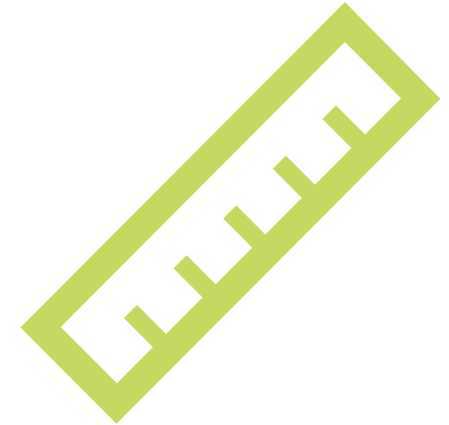

Reduced Half-time	675

- All applications must include at least one aligned performance measure (output and outcome) that corresponds to the proposed primary intervention
- All applications must include Public Health AmeriCorps determined performance measures. Please see Appendix B for the performance measures.

Narratives



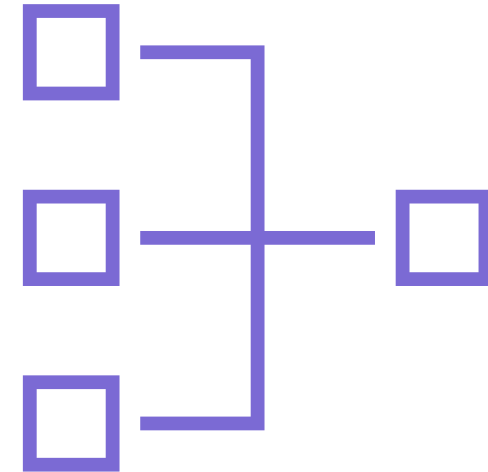
- Executive Summary
 - Follow instructions in the Notice
- Rationale and Approach (Program Design)
 - Demonstrate how AmeriCorps members and the proposed intervention are addressing identified community problem
- Organizational Capability
 - Organizational background and staffing and structures
- Cost Effectiveness and Budget Adequacy
 - Degree to which the budget is cost effective and appropriate

Note: Enter N/A for Evaluation Summary or Plan, Clarification Summary, Amendment Justification, and Continuation changes as these will be used at a later date



The Logic Model

- Summary of the community problem
- Inputs or resources that are necessary to deliver the intervention
 - Locations or sites
 - Number of AmeriCorps members
- Core Activities
 - Duration
 - Dosage
 - Target population
- Measurable outputs that result from delivering the intervention
- Measurable outcomes that demonstrate changes in Knowledge/skill, attitude, behavior or condition



Page Limits



- Narratives
 - Applications cannot exceed 10 double-spaced pages
 - Multi-State applications with more than 5 operating sites cannot exceed 12 double-spaced pages
- Sections that count toward the page limit:
 - SF- 424 Face Sheet
 - Executive Summary
 - Program Design, Organizational Capability, and Cost-Effectiveness and Budget Adequacy narratives
- Sections that do NOT count toward page limit:
 - Budget
 - Performance Measures
 - Required documents
- Logic Model- cannot exceed 3 pages

✓ **Tip: Print out your application from eGrants to ensure you are within the appropriate page limit**
